# A. NEW WELL FREEDOM VILLAGE

Carol Lathrop announced her immediate retirement as the water operator for Freedom and Independence villages. The water services are to be taken over by La Framboise Water Service Inc. Also, to be in compliance with state law, Freedom Village will need to have a second well drilled on site. La Framboise has given an initial estimate of \$15,000-\$20,000. MOTION by Commissioner Roemmele, seconded by Commissioner Macher, to have La Framboise immediately take over the water services for both villages. Voice vote. All in favor. MOTION CARRIED.

MOTION by Commissioner Macher, seconded by Commissioner Brower, to have La Framboise begin the procedures to drill the second well at Freedom Village. Voice vote. All in favor. MOTION CARRIED.

# B. ONE CALL SYSTEM

ED introduced the idea of having a one call system, where announcements are made immediately to a list of numbers, to keep the tenants and commissioners up to date on

important announcements for the communities. There were several types of plans but ED suggested one in which calls are paid for only when used to keep costs down. MOTION by Commissioner Brower, seconded by Commissioner Macher, to accept the pay as you go plan for the one call system. Voice vote. All in favor. MOTION CARRIED.
