Bob Manfredi, Hillcrest Retirement Community, Uncasville, a 20 year resident of the Town, questioned the unusual aspects of the BOE Budget, including the School's fiscal year budget, which runs from October 1 to October 1 while the Town's fiscal year budget runs from July 1 to July 1, leaving them with more funds than previously thought. He also commented on the dishonesty of municipal departments and school districts, which traditionally spend all of their funding due to the fear of losing the funding for following years.

Brian Levesque, Superintendent, Montville Public Schools, provided a brief presentation of the BOE's proposed budget for fiscal year 2017-2018, which, he clarified, runs from July 1 to June 30 and is a needs-based budget. He stated that in February 2017, the BOE approved a budget of \$38,390,619.00, an increase of \$691,951.00 or 1.84% from the BOE's fiscal year 2016-2017. Following the offering of an early retirement incentive program, a total of five retirements were received, amounting to a total savings of approximately \$230,000.00 and reducing the budget increase to 1.23%. He stated that the BOE's funding increases, which has averaged less than 1% each year over the past several years, is well below the State average, reflecting that they have been and continue to be fiscally responsible. He also reviewed the actual and projected enrollment of students since 2000, which reflects its constant fluctuation, and the average class sizes. Driving the budget increase for the next fiscal year are such items as Certified and Paraprofessional Salaries; Health Insurance; Purchased Services, e.g. Magnet Schools; Legal Fees; Contracted Services; Tuition, e.g. Special Education outplacement; Instructional Equipment, and; by popular demand, the reinstatement of Middle School Sports. Budget reductions include Rollover Savings; elimination of two Elementary School, one Middle School, and one SPED Teacher; reduction of the High School French Teacher from 1.0 to 0.4; elimination of one Maintenance Worker and one Central Office Secretary; reduction to Nursing Services, SPED Transportation, SPED Transition Program (in-district program to be instituted), and; Supplies. He stated the importance of investing in the future of the Town and educating our children. He looks forward to working with the Town Council and invited them to come speak with him at anytime to discuss any budgetary matters.

Howard R. Beetham, Jr., 60 Riverview Road, Uncasville, commended the Superintendent on a nice presentation. He commented on the rising unemployment, industries lost, the \$2 million owed in back taxes, rising cost of electricity, and the exodus of many of its residents due to their inability to afford the high taxes. Making up approximately 40% of the population, he estimates that senior citizens, whose average Social Security check is \$10,000.00/year, are one of the biggest taxpayers in the Town. He questioned the increase in the BOE budget while the average number of enrolled students continues to decrease and cited a recent article in the newspaper noting the BOE budget for the wealthy town of Stonington, which, he stated, is less than that of the town of Montville. He urged the Town Council to keep the BOE budget flat as, in this changing world, the residents of Montville cannot afford the rising taxes.

In response to Mr. Manfredi, Superintendent Levesque stated that the BOE is requesting an additional \$461,000.00, not \$700,000.00, from the current year's budget.

Chairman Jaskiewicz asked three times if there were any additional persons from the public who would like to speak regarding the Board of Education Budget.

Chairman Jaskiewicz thanked everyone for attending and stated that the Town Council and Finance Committee will work together with the Board of Education to determine a fair and acceptable budget.

5. Adjournment

Meeting was adjourned at 6:19 p.m.
