#### 8. Guest Speaker – Attorney John Chase, Town Historian

J. He also talked about the role of the church as part of the Town's Plan for Conservation and Development and the establishment of an entity to take care of the church structure. # i. SBA Committees.

Longton was mailed to Mayor Jaskiewicz regarding the traffic issue at the intersection of Routes 85 and 161 from Lakewood Drive to Daisy Road. Secondly, he obtained from M. Vlaun the list of new businesses opened in 2009.
