- b. Montville rebranding progress with other town entities
 - i. EDC Chairman White, yielded the floor to Superintendent of Montville Schools Mr. Brian Levesque
 - Discussed School strategy on mitigating Montville student losses to magnet schools to include; \$10,000 on a promotional video and website overhaul, number of losses trending upward, and his role in the goal of getting Montville students back in the public schools.
 - The EDC asked a series of questions pertaining to rankings, trends of other regional schools gain/losses to the magnet schools and who was analyzing factors in our school's rankings.
 - The response by the EDC to Mr. Levesque led the fact there is a lot of valuable analysis that needs to be conducted on free data that is available. This will ensure future spending on school marketing and branding are directed at the right areas to maximize return on investment by the town.
 - EDC left it was we will continue to work with the board of Education on data mining analysis to provide guided recommendations to improve school retention.

 - Town Council Liason McNally offered assistance to procure the best location in town once a date was set
 - The driving factor for the date will be the availability of CEDF, SCORE and SBDC entities to be present.
