For the Mothers Day tag sale date Chris Lawton was able to arrange to have Plant Lot attend with their truck to set up and sell plants. Plant Lot will donate $25 \%$ of all sales to the park. Everyone agreed this is the best option.

## c. donation bins

We received another \$75 cash from our donation bin at Quaker Hill package store.
Chris Lynch said he had four bins and four locations ready to help us raise money. Chris Lawton will forward Chris Lynch a copy of the flyer that is to be attached to the donation collection bin.

## d. Top dog contest

The owner of Quaker Hill Package store as presented us with a proposal to host a wine tasting/beer tasting event. He would get the publicity for his new business and we would get the proceeds from ticket sales. We asked Ryan to address this with the P\&R Commission to find out if we would be allowed to participate in the event.

Patty Williamson asked to take a leave from committee duties. She will need to step down as our Fundraising Chair. Chris Lawton asked if anyone else would like to step into her vacant role.
