# 8. Guest Speaker – Nature's Art.

Linda and Roger Phillips, owners of Nature's Art, brought a plan to the Commission about a three-phase expansion that would add "positive economic value to the community." The proposed plan would create temporary and permanent jobs with 300+ jobs over the course of the

project. An appeal was made to the Commission for tax relief and a proposal package will be considered. A question and answer period followed the presentation.

#### b. Update from Town Planner.

M. Vlaun gave the Commissioners a list of businesses recently approved for location within the Town of Montville. She also reported on the charge by C. Longton to look into the proposal for an audit on business related personal property, discussed at the last meeting. M. Vlaun concluded that the proposal, if approved, would not impact small businesses with Montville as more that 80% have business personal property far below the \$50,000 level. B. Caron reported that the initial proposal heard by the Town Council for the same has been sent to the Finance Committee for review. Copies of *The Connecticut Economic Digest* and *The Beige Book* Federal Reserve Board summary were handed out.

J. Andriote requested clarification regarding the purpose of the Committee. C. Longton explained that the Committee would review the skills of the Commissioners to determine the ones that are available versus those that are needed. The purpose is to have a small group of

"subject matter experts" to assist the community with small business issues. C. Longton again recommended that Commissioners take the SBA training that is available and free online. Copies of the training materials will be made available to those Commissioners who do not have access to a computer. C. Longton asked Commissioners to report back next month on their progress.
