e. Trips Update

Mr. Bushway discussed various trips planned for this year, including a trip in conjunction with the Senior Center to the Christmas Craft Fair at the Eastern State Expedition fairgrounds. The trip costs \$45 and this price includes a ticket into the event, transportation and gratuity.

f. Status of tickets to the amusement parks

Mr. Bushway stated they sold a total of twenty nine tickets at a profit of fifty cents each and all unsold tickets were returned for a full refund.

g. Discussion regarding a proposed "smoke free" ordinance.

Town Council Liaison, Candy Buebendorf indicated she has not been able to locate an ordinance regarding smoke free facilities but will continue to look into it and report back to the Commission with her findings.

h. Update regarding Eagle Scout planting project at the large pavilion at Camp Oakdale.

Chairman Gwudz stated this project has not been started and he has had no contact with the Eagle Scouts for a status update.

Mr. Bushway stated he met with the organizers of the event on Monday and it is a proposed two day event consisting of a motorcycle run/rally with a carnival/fun day planned. There is another meeting scheduled in two weeks for further discussions.
