## Regular Meeting Minutes for Tuesday, May 31, 2011

#### 1. Call to Order

Murphy called the meeting to order at 6:02 p.m. Present were Gary Murphy, Billy Caron and Russ Beetham. Also present was Terry Hart, Finance Director

- 2. Murphy led Pledge of Allegiance
- 3. Remarks from the Public

Caron moved, Beetham second to add the following items to the agenda: Approve minutes of the 11/30/10; 5/3/11; 5/5/11; 5/10/11; 5/12/11 and 5/17/11 minutes. Discussion of part time fire/dispatchers salaries for the 2011-12 Fiscal Year Motion passed 3-0.

- 4. Agenda Items as follows:
- a) Discussion of Microwave Tower with Fire Marshal Ray Occhialini, Fire Marshal, explained that the microwave from dispatch to Cook Drive is not working. He has a quote from Communication Plus for \$28,421 to repair this. He has funds allocated in the Public Safety Building budget for this. Caron moved, Beetham second to recommend the Town Council approve payment of \$28,421 to Communication Plus for microwave repair and waive the bid process. Motion passed 3-0.
- b) Discussion of part time fire/dispatchers salaries for the 2011-12 Fiscal Year Occhialini discussed that the 2011-12 budget includes a 2% increase for part-time fire/dispatcher salaries. He would like to implement a 2% increase for the next three years. Beetham moved, second by Caron to recommend the Town Council approve a 2% increase for part-time fire/dispatcher salaries for the 2011-12, 20012-13 and the 2013-14 fiscal years. Motion passed 3-0.
  - c) Discussion of financing items in the Capital Plan

The committee discussed the possible financing of a jet/catch basin truck, two plow trucks and a fire truck. Hart will find out if the WPCA is interested in sharing the cost of the jet/catch basin truck. Caron moved, Beetham second to recommend the Town Council discuss and approve the financing of capital items and hold a town meeting for public discussion. Motion passed 3-0.

### d) Approval of minutes

Caron moved to approve the minutes of the 11/30/10; 5/3/11; 5/5/11; 5/10/11; 5/12/11 and 5/17/11 minutes. No second motion failed. Beetham moved, second by Caron to table this item until the next meeting. Beetham/Caron in favor, Murphy opposed. Motion passed.

# e) Discussion of 2011-12 Budget

The committee held a discussion regarding the state budget. They also discussed the funding for roofs in the 2011-12 Capital Plan. Caron moved, second by Beetham to recommend the Town Council reduce the funding for the Old Town Hall Roof repair from \$75,000 to \$60,000; reduce the funding for the New Town Hall Roof repair from \$30,000 to \$20,000; and establish a line for the Montville Road Bridge Repair and fund it at \$25,000 in the 2011-12 Capital Improvement Plan. Motion passed 3-0.
