- **1.** Call to Order. Chairman Pieniadz called the September 25, 2012 meeting of the Montville Planning & Zoning Commission to order at 7:00 p.m. in the Town Council Chambers.

Hendel's, Inc.: An application for a Site Plan Review for convenience store modifications including the construction of a 1251 sq. ft. addition with drive through facility, one fuel pump and associated parking, landscaping and site work located on the property at 2210/2200 Norwich-New London Turnpike (Route 32), Montville, CT As shown on Assessor's Map 103 Lots 30 and 31.
