Town of Montville Parks & Recreation Commission Meeting Minutes Wednesday, December 19, 2012 7:00 pm – Town Hall – Town Council Chambers

1. Call to order

- a. Trick or Trunk review

Very successful event. Only real issue/complaint was lack of parking due to overwhelming attendance. Discussion followed. Suggestion made that a cut off entry time be established for all participants. Some other input included moving the sound system to a more centralized area of event, install port-o-let unit in a better lit location, more trash containers and perhaps an age cut off.

b. Family Letterboxing review

Great response to October 21st event. 83 people attended and Boy Scouts assisted.

c. 2013 meeting dates

Meeting time has changed to 6:30 pm. Commission voted to eliminate August meeting at this time. Laura Tanner checking on November meeting date location. Our annual walkthrough will be at 6:00 pm on Wednesday, May 15th.

Motion made by Commissioner Hillman to approve meeting dates and time change. Seconded by Commissioner Lawton. Approval was unanimous.

d. Winter booklet

Currently at printer's – will be distributed early January. This booklet will cover events from January thru April.

8. New business

a. Budget and CIP needs

Recreation director's salary is incorrect in current budget. Should read \$69,455.00 as per the contract. Budget reflects a zero percent increase. No plans to restore office secretary to full time position. Discussion followed regarding summer camp bus transportation. Most kids used buses only for returning home. More discussion to follow. Camp fee is being raised to \$50.00 for 2013. CIP basically the same. Commissioner Perkins questioned why \$44,000 for restrooms is so far out and developing new multi-use trail is a priority. Commission added land acquisition to Capital Improvement. Commission unanimously accepted the proposed budget.

Commissioner Hillman stated that there are holiday items stored in attic at Public Works garage. Commissioners delaCruz and Lawton will make an appointment to view these and determine if some can be used in 2013.

c. Youth Basketball update

Approximately 197 kids in program. Practice has started and regular scheduled games will begin in early January. Shortage of volunteer coaches.

d. Town-wide special event

Commissioner Lawton is interested in reviving a Fall Fest. Would be a three-day event (Friday – Sunday) to consist of rides and food concessions. Looking to start with a small scale event and build up. A lively pros-cons discussion ensued. Would we have enough personnel to handle the scope of the event? In-kind services probably not available and expenses could run around \$8,000.00 Chairman Cicchese made motion requesting further exploration of this community event. Commissioner Hillman seconded. Commissioner Geiler will check with Lions Club regarding their potention involvement.

e. Easter Egg Hunt

Established the following Saturday, April 6th as rain/snow date.
