1. <u>Call to Order.</u>

Commissioner Jetmore called the meeting to order at 7:00 p.m.

3. Roll Call.

- 5. <u>Communications: Copies of monthly statistics reports from Fire Departments, Fire Marshal, Police, Animal Control, and Building Official.</u>

Commissioner Jetmore asked and confirmed that the monthly reports were received by all of the Commissioners. These reports were dispersed electronically.

8. Remarks from Department Heads.

Lt. Bunnell reported that there has been a two-week extension for the trainees to repeat one of the four phases. One candidate is still attending the Academy and two seats available there in December. Five conditional offers were presented with five more to review from the last group of applicants. The Trick-or-Truck event on Saturday, October 31st went smoothly and parking areas were full. Approximately, 1500-2000 people attended the event. Lt. Bunnell thanked the fire and police personnel for their presence. He also reported that he is updating the existing uniform policy that will be brought to the Commission for consideration and action.

Commissioner Adams reported that she and Commissioner Perkins had their last meeting with the fire chiefs on Thursday, October 29th regarding the Public Safety Report. Commissioner Jetmore thanked everyone for attending the meeting this evening, G. Gathers for her work with the Commission, and wished everyone a safe Halloween.

Responding to a question about dispatch from Commissioner Allyn, Mayor McDaniel stated he is working on the problem and is hoping to add enough new people to the handle the issue.
