Mayor Jaskiewicz reported on the following: 1) bid request for work to be done on Oxoboxo Dam Road was sent out today and deadline for response is November 15, 2009; 2) Town was awarded the STEAP Grant for community center improvements; 3) Impulse Design has been contracted to make upgrades within interiors of some Town buildings; 4) energy grant has been approved; and 5) Mystic Air Quality has been contracted to remove asbestos on Town-owned properties that are scheduled to be demolished.

Finance Director, Terry Fafard, reported on the following: 1) Town has received a AA Moody Rating for bonding. It has been recommended that no additional funds be used from General Fund Balance for the next three months; and 2) \$12,000,000.00 bond due on October 29th, after 15 day waiting period. Councilor Beetham inquired if the WPCA has begun making payments to the Town, and Ms. Fafard stated that no payments have yet been made. Mr. Brian Molinari, 68 *Kitemaug Road*, addressed the Council and stated that the Blighted Premises Ordinance as approved is flawed, specifically regarding the large fines imposed.

Councilor Geary stated that since it is the last meeting of the Town Council before the election in November, he thanked the Mayor and his staff for work on the budget and for the work in receiving the grants that the Town has.
