#### A. INCOME RESOLUTION

Where it is desirable and in the best interest of the State of Connecticut, the Housing Authority of the Town of Montville, and the elderly citizens of the State of Connecticut, BE IT HEREBY RESOLVED THAT:

1. Effective September 18, 2018, the maximum income limits for applicable state-assisted elderly and congregate elderly housing facilities owned by the Housing Authority of the Town of Montville shall be the low income listed in the area in which such housing facility is located based on the US Department of Housing and Urban Development's published public housing guideline. The maximum income allowable for occupancy is:

For one person \$50,350 For two people \$57,550

This resolution rescinds and replaces any and all previous resolutions
established maximum income limits for application and continued occupancy
for all applicable state- assisted elderly and congregate elderly housing
owned by the Housing Authority of the Town of Montville.

Commissioner Szarzynski motioned, seconded by Commissioner Brower, to pass the resolution. Voice vote, All in favor, MOTION PASSED.
