# Town of Montville Board of Assessment Appeals Regular Meeting Minutes September 14, 2019 – 9:00 a.m. Room 203 – Montville Town Hall

All persons claiming to be aggrieved by the doings of the Assessor of the Town of Montville with regard to motor vehicle assessment on the Grand List of October 1, 2018 are hereby warned to make their appeal to the Board of Assessment Appeals at this meeting.

1. Call to Order

Chairperson Turner called the meeting to order at 9:00 a.m.

2. Roll Call

Present were Board Members Joe Aquitante, Gary Murphy, and Florence Turner and Alternate Member Joan Paskewich. Also present was Town Assessor Lucy Beit.

## Sean Decora, 2001 Ford F-150 XLT Extended Cab, Account #53940

Sean Decora was sworn in by Chairperson Turner. Mr. Decora requested an adjustment to the assessment of the vehicle due to its extensive mileage (over 400,000 miles) and is currently being supported by blocks.

Motion made by Board Member Turner, seconded by Board Member Aquitante, to reduce the assessment from \$3,150.00 to \$1,175.00. Discussion: None. Voice vote, 3-0, all in favor. Motion carried.

## Robert Manfredi, 2018 Hyundai Elantra SEL, Account #59865

Robert Manfredi was sworn in by Chairperson Turner. Mr. Manfredi stated that the vehicle has not been depreciated since its purchased.

Motion made by Board Member Turner, seconded by Board Member Aquitante, to reduce the assessment from \$15,470.00 to \$13,250.00. Discussion: None. Voice vote, 3-0, all in favor. Motion carried.

## Donna M. Siggens, 2007 Toyota Corolla, Account #64269

Donna Siggens was sworn in by Chairperson Turner. Ms. Siggens stated that, though the vehicle has suffered extensive damage, it was not totaled by the Insurance Company. The Board entered into a recess at 9:25 a.m. to view the vehicle and reconvened at 9:30 a.m.

## John E. Winslow, 2009 Chevrolet Impala, Account #66775

John Winslow was sworn in by Chairperson Turner. Mr. Winslow stated that the vehicle has a salvage title, no market value, 218,000 miles, and has sustained other damage.

Motion made by Board Member Turner, seconded by Board Member Aquitante, to reduce the assessment from \$3,500.00 to \$575.00. Discussion: None. Voice vote, 3-0, all in favor. Motion carried.

## John E. Winslow, 2002 Chevrolet Silverado, Account #66774

Mr. Winslow stated that the vehicle has 188,000 miles and has a DMV Use Tax Value of \$1,700.00; the vehicle was purchased for \$200.00.

Motion made by Board Member Turner, seconded by Board Member Aquitante, to reduce the assessment from \$2,960.00 to \$1,025.00. Discussion: None. Voice vote, 3-0, all in favor. Motion carried.

## Dennis & Karen Duhamel, 2011 Subaru Legacy, Account #54513

Dennis & Karen Duhamel were sworn in by Chairperson Turner. Mr. Duhamel stated that the vehicle has 219,166 miles, is in need of \$1,700.00 worth of repairs, and is not entirely drivable.

Motion made by Board Member Turner, seconded by Board Member Murphy, to reduce the assessment from \$6,040.00 to \$4,550.00. Discussion: None. Voice vote, 3-0, all in favor. Motion carried.

# Dennis & Karen Duhamel, 2014 Mazda 4WD Touring V6 CX9, Account #54514

Mr. Duhamel stated that the vehicle has approximately 125,000 miles and, while mechanically fine, has sustained some front end damage.

Motion made by Board Member Turner, seconded by Board Member Aquitante, to reduce the assessment from \$11,620.00 to \$9,500.00. Discussion: None. Voice vote, 3-0, all in favor. Motion carried.

# Randell C. Spicer, 2003 Ford F-150, Account #64650

Randell Spicer was sworn in by Chairperson Turner. Mr. Spicer stated that he has traded in the vehicle for \$250.00 and the plates have been transferred. At trade-in, the vehicle had approximately 290,000 miles and mechanical issues.

Motion made by Board Member Turner, seconded by Board Member Murphy, to reduce the assessment from \$4,460.00 to \$2,625.00. Discussion: None. Voice vote, 3-0, all in favor. Motion carried.

# Randell C. Spicer, 2008 Chevy Cobalt, Account #64651

Mr. Spicer stated that the vehicle, which was originally gifted, was traded in for \$500.00 and the plates have been transferred. At trade-in, the vehicle had approximately 139,000 miles and had

sustained a number of bodily injuries, interior damage, and was in need of approximately \$1,500.00 in repairs.

Motion made by Board Member Turner, seconded by Board Member Murphy, to reduce the assessment from \$2,360.00 to \$1,500.00. Discussion: None. Voice vote, 3-0, all in favor. Motion carried.

## Donald Lakowsky, 1978 Kings Highway Motor Home, No Account Number

Donald Lakowsky was sworn in by Chairperson Turner. The Board reviewed photographs of the motor home, as presented by the Appellant, providing visual evidence of its condition. The motor home is not drivable and is leaking due to damage caused by a fallen tree.

Motion made by Board Member Turner, seconded by Board Member Aquitante, to reduce the assessment from \$7,210.00 to \$3,605.00. Discussion: None. Voice vote, 3-0, all in favor. Motion carried.
