The Rules:

No fee for entry into the contest.

All lights must be on by 6:00 PM Monday-Friday the second week in December for judging. Registrations must be received by December 10th.

Judging by the Montville Rotary will be based on arrangement, variety, and overall "WOW!" factor.

4 Prizes will be awarded, Grand Prize, and a First prize for each category. Winners will be notified by Friday December 13th. Prizes must be picked up at Parks and Recreation office at Town Hall.

Entries must be residents within the borders of the city of Montville.

Winter Wonderland

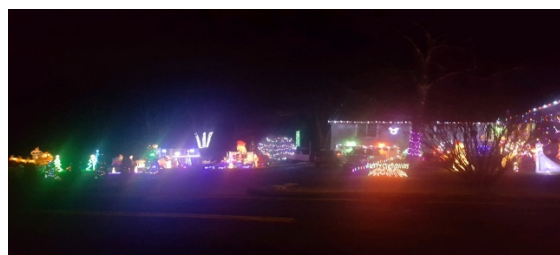
This category concentrates more on snow, winter, snowmen, and things like that and less on traditional Christmas icons.
