# TOWN OF MONTVILLE MEETING OF BOARD OF EDUCATION MONTVILLE HIGH SCHOOL LIBRARY/MEDIA CENTER November 16, 2010 at 6:00 p.m.

### Item 1. Call to order.

Board Chair David Rowley called the meeting to order at 6:04 p.m. in the Montville High School Library/Media Center. Board members present were Carrie T. Baxter, Sandra Berardy, Steve Loiler, Tom McNally, Robert Mitchell, Jr., Todd Pomazon, James Wood and David Rowley. Deborah Reed-Iler was absent.

## Item 2. Pledge of Allegiance.

#### **Presentation:** A) Montville Marvels.

### Presentation: B) Behavior Intervention Program – Tyl Middle School.

Principal M. J. Dix introduced the Tyl Student Services staff Jessica Lilienthal, Mark McGuire, Jill Paglino, Amy Richter, and Jamie Wolfradt who gave a presentation on the Tyl Behavior Intervention Program. A discussion was held concerning Rachel's Challenge which aligns with the District Improvement Plan fostering acceptance and tolerance and is supported by the Montville Education Association, the Montville Youth Services Bureau, the Montville Education Foundation and the community.

### Item 5b. Budget Projection – Kathy Lamoureux.

P. Aubin reported on the current year budget projection as of October 31, 2010 which the Board received in its packet. The Board has expended \$8,767,117 or 24.17% of its annual budget appropriation of \$36,270,035.

### Item 6. Report from Student Board Representatives.

Student Board Representatives Jessica Semmelrock and Matthew Clark gave a report to the Board as follows:

- 1. The second quarter has begun and report cards for last quarter were mailed home last week.
- 2. Juniors in American Studies I are collecting items from a list given to them by Lieutenant Nicholas Orzechowski to send to a platoon in Afghanistan. The Lieutenant noted that there were some platoon members who do not receive mail or packages from home.
- 3. The Future Business Leaders of America (FBLA) are collecting old cell phones that will be recycled and shipped with prepaid phones and prepaid cards to soldiers.
- 4. The FBLA is also sponsoring a scavenger hunt to celebrate small businesses and entrepreneurs and bring awareness to American enterprise.
- 5. The National Honor Society has asked students to support the Montville Food Bank by donating a canned food item, and students who participate will be allowed to wear their favorite hat.
- 6. Student Government has collected canned food items at the last two football games and received donations from fans to help support the Montville Food Bank.
- 7. Tashi Dhundup, a 2010 MHS graduate, has graduated from the Marine Corps Recruit Training course in Parris Island, SC. Tashi was his company's honor graduate receiving a promotion to Private First Class, and his goal is to make the Marine Corps his career, earn a college degree to attend Officer's Candidate School and become a U.S. citizen.

- 8. Physical education and health classes will sponsor Hoops for Heart on November 22 and 23.
- 9. In an effort to reduce hunger, culinary classes are raffling off fixings for Thanksgiving dinner.
- 10. The Gay Straight Alliance will sponsor a food drive in December to support Alliance for Living.

- a. Report from the Director of Student Services Ms. Maynard.
- The district received feedback from the State Department of Education on focus monitoring. Based on a rubric, the district scores fluctuated from 1 to 5 with an overall average of proficient and above.
- Nurse interviews were conducted this afternoon for a special needs position.
- Apprised the Board of the new group home that will be opening in the district and potential costs from future students.

### b. Report from Assistant Superintendent – Mr. Levesque.

- Apprised Board that Mr. Marelli will take 20 students on a snowboarding trip on January 14 17, 2011. This information was received today.
- Training on X2Aspen data software for staff was completed today. Data conversion is nearly complete. There will be no access to data on either software, old or new, on December 3. The go live date has been readjusted to December 6. He thanked Nick Savoie for his help.
