c. From the EDC Liaison.

B. Caron suggested that the Commission sends a letter to the Town Council asking them to fill the vacancies on the Commission. He will also contact one of the recommended candidates, Willis Pike. B. Caron also announced that he is not seeking election for Mayor in November but would seek reelection to the Town Council and liaison for the Commission. Additionally, he praised the work and efforts of the Commission that he described as "renewed."

Item 11. New Business

a. New effort to stimulate hiring in local business (Commissioner Longton). This item was moved upon on the agenda without objection.

C. Longton proposed that J. Toner to ask the small businesses what it would take for them to hire or rehire one new person. Discussion followed that many long-term businesses are "cash rich" but not hiring new employees. Some are bringing in family to help. J. Toner talked about the federal and state incentives that are available for businesses to hire full-time employees and what small businesses need to know in order to add new employees—reduce cost, increase demand and test the market. B. Caron suggested that this information to the businesses come from the Commission and is added to the Town website. He also urged J. Toner to contact the reporter for the Montville Times to publicize the Commission's efforts and the Commission to utilize its budget for business cards and pamphlets for use with its small business survey. B. Caron also gave him a contact for name tags. J. Toner added that he has the time to devote to the project but needs a partner to help with it.
