QUARTERLY REPORT</u>: ED distributed the quarterly report for the period ending December 31, 2012 and it was noted the operating gain was \$40,566.58, mainly due to income of \$10,000. over budget and Contractual expense of \$24,000. under budget (low snow removal cost was the chief savings).
