Item 1. Call to order.

Travis with a proclamation on behalf of the CT State Assembly. Representative Ryan commented that Ms. Travis would also be recognized by the Montville Rotary. Superintendent Levesque then called upon the 2014 Teacher of the Year Robin Tamburrino, who presented the Montville Teacher of the Year plaque to Kalyn Travis. Mayor R. McDaniel then thanked K. Travis for the work she has done with the special education students and presented her with a "smaller award" on behalf of the Town of Montville. Board Chair D. Rowley presented the Teacher of the Year "golden apple" that will be returned to J. LeMay for engraving.

Item 5. Report from Student Board Representatives.

Student Board Representatives, senior Rohit Sinha and Karishma Chouhan, the new junior class representative, reported to the Board on the following:

- 1. Students were welcomed back to school on August 26, 2015.
- 2. Students had their first advisory session on September 9th where they set goals for the new school year.
- 3. Back-to-School Night will be held tomorrow, September 16th.
- 4. The Class of 2017 will be having a tag sale at Fair Oaks to raise money for their class.
- 5. Spirit Week, organized by Student Government, will take place next week. Student Government has been working hard to organize the event and the fall pep rally leading up to the Homecoming Dance by speaking with administration, organizing decorations, and begging teachers to chaperone the dance. The half day on that Friday will allow for a catnap before the big game.
- 6. The "True Homecoming" football game is being held on Friday, September 25th and over 80 Montville alumni from 1965-1970 will be attending the event. A tour and concert will also take place on that date.
- 7. MHS teachers and administration are taking the initiative to help students develop skills and strategies in problem solving.
- 8. On Saturday, September 12th, the Montville Marching Band attended UConn Band Day at Renschler Field in East Hartford. They were joined there by over 800 high school band students from around the state in performing with the UConn Marching Band during halftime at the UConn v. Army game.
- 9. A Men's Choir and JV Acapella Choir have been added to the choral program and are going remarkably well.
- 10. The Drama Department is holding auditions for the female roles in *The Odd Couple* by Neil Simon.

Board Chair D. Rowley commented that some of the Board goals are similar if not word for word. He said that they wanted to have music education be considered as a "focal point of interest" in the district/curriculum and will have the Board Secretary see that it is moved forward. He also asked for the reinstatement of "senior community project" be reconsidered for the district.

b. Report on state assessment results from Laurie Pallin.

Assistant Superintendent L. Pallin gave a PowerPoint presentation giving an overview of assessment results that were received late and are just now being reviewed. Upon a thorough review of the results a follow up presentation will be given along with the CAPT results and results from Smarter Balanced assessments. Per a preliminary review, district participation in English, mathematics, and reading are at 98%, two percentage points above the state with results near or right around State levels. Students are being pushed toward results that are "good" not "proficient". L. Pallin gave a breakdown of the categories that make up the scores for the new state assessment. She also commented on the SAT and its new format and the PSAT that is being offered to sophomore and junior students each fall toward a growing readiness for college. In response to questions by the Board Chair D. Rowley, L. Pallin responded that videos are available for parents to assist students with their homework. She also responded that the report on DRGs is in Dropbox adding that the State has not recalculated the DRGs.

c. Special Education Presentation on the IEP process.

Director of Special Services M. Johnson accompanied by Denise Dunning and Jennifer Russell gave a PowerPoint presentation on the IEP Process. In his presentation, M. Johnson gave an overview of the process toward completing the multi-page IEP. He stated that the basics of IEP are "foundation" and "specialized" declaring that everything should be built around these tenets when "a group of people who care about a child to give them access to education." M. Johnson added that the importance of specialized instruction is focus goal driven targeted to the needs of individual students that includes measurable goals, strengths and weaknesses, annual goals, meetings with students, and parental involvement. Board member D. Reed-Iler praised the "amazing amount of work" done by the department. M. Johnson praised D. Dunning and J. Russell and spoke of their ability to work hard and think smart to do the right things for the students.

L. Pallin reported to the Board on the following:

• <u>District-wide Academic Goal</u>: We have begun work on our district-wide academic goal to develop students who are effective problem solvers and persevere while solving problems. Most buildings have decided to begin their work by focusing on helping students gain evidence to solve problems by implementing active reading strategies. Students will be expected to annotate a text and take effective notes to enable them to apply their information read to solve a problem. The schools are also continuing work to cultivate grit and a growth mindset in students.

c. Monthly Update.

B. Levesque reported on the following:

- <u>Legislative Changes</u>: I continue to read and research the legislative changes. I attended a session with Shipman and Goodwin on this last week. There are some significant changes to curriculum and other school district operations that we are trying to understand. I expect bring some policy issues to the Policy Committee next month as a result of some of the changes.
- Water at MHS: We have a meeting tomorrow with our water consultant and Lamframboise Wells to discuss the test well that was drilled at MHS
- <u>MAA Negotiations</u>: We reached a tentative agreement with the MAA last night. They will be meeting to ratify it in October. I expect that it will be on the agenda for the board's approval at the October meeting.
