THE TOWN OF MONTVILLE HEREBY RESOLVES to amend Resolution #2022-09 and to refund the amended list of taxes due to overpayments and corrections in the amount of \$7,099.59 (seven thousand ninety-nine dollars and fifty-nine cents) as requested by the Tax Collector. (Councilor McNally) Motion made by Councilor Rix, seconded by Councilor May. Discussion: Councilor McNally stated that the resolution is to correct the approval amount of the previous resolution. Roll Call vote, 6-0, all in favor. Voting in Favor: Councilors Bunnell, Mandler, May, Rix, Yuchniuk, and McNally. Voting in Opposition: None. Resolution passed.
- c. Resolution #2022-21. THE TOWN OF MONTVILLE HEREBY RESOLVES to approve the proposed list of expenditures related to the American Rescue Plan funds, as recommended by the COVID-19 Impact Study Committee. He added that the Fire Marshal's request for two vehicles, totaling \$106,106.22, was moved to the second phase of ARPA Funding. In response to Councilor Rix who questioned the need for the fingerprint machine, Councilor Bunnell stated the fingerprint machine would be an additional machine that would allow the Police Department to have a machine in two areas – front area and detention area – in the building. He estimated that the Police Department has had a fingerprint machine for approximately 15 years. The new machine will be electronic, as required by the State. It is expected that the Rules and Regulations will soon be required by all Police Departments for accreditation. Based on his recent conversations with the Fire Marshal, he expressed his support for the Fire Marshal's request for two vehicles due to their ongoing issues and high mileage. Roll Call vote, 6-0, all in favor. Voting in Favor: Councilors Bunnell, Mandler, May, Rix, Yuchniuk, and McNally. Voting in Opposition: None. Resolution passed.
