### **Correspondence & Communication**

- **Email Poll to Approve GLA Budget rev1:** Poll dated 1/3/2022 to include two paid invoices for lake studies was ratified by consensus. The motion passed 7-0. The approved, revised budget was disseminated. The 2021 projected budget will be updated to final.
- **Email Poll to Approve ECCD AIS Grant Application:** Poll dated 2/2/2022 to authorize the Eastern CT Conservation District (ECCD) to proceed with an Aquatic Invasive Species grant application in partnership with the Gardner Lake Authority was ratified by consensus. The motion passed 6-0.
- **Letter of Support for AIS Grant to DEEP's Madeline Ortiz:** Dated 2/2/22 from the GLA Chair and the three chief town officials in support of GLA's participation in ECCD's AIS application.
- **Invoice from Kate Johnson:** Kate submitted an invoice, dated 3/10/2022, for reimbursement in the amount of \$152.06 for printer toner. Chris Rios made a motion to approve payment; seconded by Bill Wrobel. The motion passed.
- **2022 Invoice to Towns:** Mailed to the three towns on 1/7/22.
- **Letter from Sue Coffee, Friends of Gardner Lake, to Mike Lambert, DEEP:** Received (cc'd) on 1/24/22, regarding fishing tournaments.
- **DEEP Notice of Intent to Amend Regulations & Notification of Public Hearing:** Regarding changes to include Open Fishing for certain fish species including trout (but not bass).
- **Email from Bozrah First Selectman Glenn Pianka:** Dated 3/6/22, in recognition of the spirit of cooperation shown between GLA and CT DEEP [as noted in the Special Meeting minutes].
- **2022 ECS/GZA Water Quality Monitoring Proposal:** Dated 9/28/21, in the amounts of \$8,275 for water quality monitoring and \$1,750 for data logging MiniDOT instruments to be anchored in the deep hole off the island. The MiniDOT would provide insight into lake stratification, fluctuations in temperature, dissolved oxygen concentrations, seasonal oxygen depletion rates and deep-water anoxia

(abnormally low levels of oxygen). Kate Johnson made a motion to approve the contract; seconded by Chris Rios. The motion passed unanimously.
