*Whereas*, the Town Council held Public Hearings of the Board of Education proposed budget on April 28, 2022, and the General Government proposed budget on April 27, 2022, in accordance with the provisions set forth in the Charter of the Town of Montville.

*Now Therefore, Be it Resolved*, that the following budget on the estimated cost of current expenses for the fiscal year beginning July 1, 2022 and ending on June 30, 2023, to be adopted as follows:
