## AN ORDINANCE REGARDING THE CONVEYANCE OF FORT SHANTOK ROAD (EAST), SUNNY HILL DRIVE AND A PORTION OF SHANTOK HEIGHTS ROAD

#### THE TOWN OF MONTVILLE HEREBY ORDAINS:

#### Section 1.

The Mayor is hereby authorized to convey by Quit Claim Deed Fort Shantok Road (East), Sunny Hill Drive and a portion of Shantok Heights Road to The Mohegan Tribe of Indians of Connecticut for no consideration, but on the terms and conditions contained in an "Agreement Concerning Road Discontinuance, Property Transfer and Snow Removal Obligations" by and between The Mohegan Tribe of Indians of Connecticut and the Town of Montville dated August 13, 2021. The roads are further described on Schedule A attached hereto.

#### Section 2.

The Mayor is hereby authorized to execute and deliver a quit claim deed to said roads; which deed shall be approved by the Town Attorney as to form, content and legality. The Mayor is also authorized to execute such other documents as are required to complete the conveyance of said roads and to carry out the purposes of this Ordinance.

#### Section 3.

This ordinance shall become effective thirty (30) days from the date of its adoption.
