WARNING OF ELECTION - November 8, 2022 State Election

The Electors of the Town of Montville are hereby warned to meet at their respective polling places in said town on Tuesday, November 8, 2022, for the following purposes:

- I. To cast their votes for Governor and Lieutenant Governor, United States Senator, Representative in Congress, State Senator, State Representative, Secretary of the State, Treasurer, Comptroller, Attorney General, Judge of Probate, and Registrar of Voters.
- II. To vote on the following question for the approval or disapproval of a proposed AMENDMENT to the Constitution of Connecticut, a vote of "YES" being a vote for approval, and a vote of "NO" being a vote for disapproval:
- 1. Shall the Constitution of the State be amended to permit the General Assembly to provide for early voting?

The full text of such proposed questions with explanatory text, printed in accordance with \$2-30a of the General Statutes, is available at the town clerk's office for public distribution. The vote on the proposed questions is taken pursuant to the Constitution of Connecticut.

- III. To vote on the following local questions:
 Pursuant to Section C709 of the Town Charter of the Town of Montville and Chapter 152 of the Connecticut General Statutes, notice is hereby given to the electors and eligible taxpayers of the Town of Montville qualified to vote that a referendum will be held on Tuesday, November 8, 2022, at the below listed voting districts between the hours of 6:00 a.m. and 8:00 p.m., for the purpose of approving or disapproving the following two questions a vote of "YES" being a vote for approval, and a vote of "NO" being a vote for disapproval:
- 1. "Shall the Town of Montville appropriate \$7,000,000 for school infrastructure projects, including (a) Roof Replacement, Caulking of exterior joints and windows, Rooftop Air Handlers and Boiler Replacement at the Tyl Middle School, (b) Window Replacement at the Mohegan Elementary School, (c) Fire Alarm Panel Replacement at the Murphy Elementary School, and (d) Roof Replacement Above Gym and Vocational Room at the Palmer School, and authorize the issuance of general obligation bonds and notes in the same amount to finance said appropriation?"
- 2. "Shall the Town of Montville appropriate \$1,000,000 for the High School projects, including (a) Tennis Court Replacement, and (b) Track Replacement, and authorize the issuance of general obligation bonds and notes in the same amount to finance said appropriation?"
