- f. Consider and possible action on \$3K for P&R Sound System

 Motion made by Councilor Caron, seconded by Councilor McNally, to approve the
 allocation of \$3,000.00 for the Parks & Recreation Sound System. Discussion: None.
 Voice vote, 3-0, all in favor. Motion carried.
- g. Consider and possible action on \$40K for Polish Club needs
 Motion made by Councilor McNally, seconded by Councilor Mandler, to approve the
 allocation of \$27,000.00 to the Polish Club for all of the upgrades, with the exception
 of the guardrails. Discussion: None. Voice vote, 3-0, all in favor. Motion carried.
- h. Consider and possible action on request from Housing Authority for \$30K for Bathroom Renovations
 Motion made by Councilor McNally, seconded by Councilor Caron, to approve the allocation of \$30,000.00 for Bathroom Renovations. Discussion: In response to Councilor Caron, Social Services Assistant DeeAnn Morton stated that the Authority maintains a revolving account through the Connecticut Housing Finance Authority (CHFA). She also stated the need for ADA-compliant bathrooms to reduce their liability and improve the safety of its residents, citing that three of their residents had fallen in the bathrooms within the last three months. Voice vote, 3-0, all in favor. Motion carried.
- Consider and possible action on request for \$15K for SS and Senior Citizens for Mental Health Counseling
 Motion made by Councilor Caron, seconded by Councilor McNally, to approve the allocation of \$15,000.00 for Social & Senior Services for Mental Health Counseling.
 Discussion: Chairman Mandler explained that \$30,000.00 was allocated to Youth Services and Social & Senior Services. Due to the pandemic, there is an increased need for mental health counseling. As such, the Social & Senior Services Department requested an additional allocation of \$15,000.00. Voice vote, 3-0, all in favor. Motion carried.
- j. Consider and possible action on \$500k to offset next year's budget Motion made by Councilor McNally, seconded by Councilor Caron, to allocate \$500,000.00 to offset the FY2023/24 Budget. Discussion: To help offset the rising fuel, heating oil, and electricity costs the residents are experiencing, the funds would help the Town lessen the residents' burden by keeping its mil rate down. Voice vote, 3-0, all in favor. Motion carried.

k. Consider and possible action on reallocation of \$5K from affordable housing to Plan of Conservation & Development

Motion made by Councilor McNally, seconded by Councilor Caron, to re-allocate \$5,000.00 from the Affordable Housing Plan to the Plan of Conservation and Development. Discussion: Land Use and Development Director Liz Burdick requested that the balance of \$5,000.00 from the previously allocated \$15,000.00 for the drafting of the Affordable Housing Plan be reallocated to draft a revised Plan of Conservation & Development with the latest census information. Voice vote, 3-0, all in favor. Motion carried.

1. Consider and possible action on canceling meetings until June 2022 for reevaluation of projects and funds and possible action

Motion made by Councilor McNally, seconded by Councilor Caron, to cancel the Ad-Hoc COVID-19 Impact Study Committee Meetings until June, 2023. Discussion: Finance Director Barbara Griffin reported that she has been working on a spreadsheet indicating the funds that were allocated and expended to date, to determine the actual status of the ARPA Funds. Councilor McNally added that some of the numbers do not coincide due to the rising cost of the items. A brief discussion ensued regarding the funds that were allocated to the Board of Education. Voice vote, 3-0, all in favor. Motion carried.
