Chairman McNally asked three times if there was anyone from the public who would like to speak regarding the proposed General Government Budget for FY2023/24.

Raymond Library Board Treasurer Paul McGlinchey, 37 Forsyth Road, spoke in support of the Library's budget request. The Library's current annual operating budget is approximately \$165,000.00/year, \$65,000.00 of which is provided by the town. The remaining funds derive from their endowment which has steadily decreased by 25% over the last 12 years.

Eventually, no funds will remain to support the Library and will have to cease its existence without any additional funding.

Ellen Abutin, 19 Hickory Drive, spoke in support of the Raymond Hill Library Budget. She concurred with Mr. McGlinchey and invited everyone to visit the Library and witness their unbelievable events and activities. As one of the best things the town offers, it would be a significant loss should the Library be forced to close due to lack of funds. The community, special guest speakers, event hosts, and staff could attest to its importance. She also suggested the possibility of housing the town's Historical Society in the building and combining their efforts and urged them to begin thinking more creatively.

Raymond Library Director Kari Wall stated that the staff has been working very hard to meet the needs of the community. Since March, they have held 59 programs serving 1,051 attendees, including their Weekly Storytime, which was recently expanded. They recently partnered with the Tantaquidgeon Museum and Mohegan Tribe, Montville Youth Service Bureau, Montville Police Department, 2-1-1 United Way, Southeastern Regional Action Council (SERAC), and local Girl Scout Troop to hold various programs. Through these partnerships, they are hosting local history, foraging, and mental health programs. In addition, their Summer Reading Program continues to grow. They are continuing to explore their partnerships as they seek to meet the needs of the community. They will be hosting their 2nd Annual Pirate FundFest at the Camp Oakdale Large Pavilion this year. She recited the Library's Mission Statement, stating that their goal is to not only provide materials, but also valuable programming – both of which are becoming increasingly difficult due to their funding issues. Increased funding would allow them to increase their programming and hours of operation to better serve and meet and grow with the community and its needs.

Ray Coggeshall, a longtime Library Board of Directors member, also spoke in support of The Raymond Library, an important institution in the Town of Montville. The Library has been running at a deficit for over ten (10) years and is in dire need of balancing its budget and it is hoping to do so with incremental annual increases from the town.

Chairman McNally asked three times if there was anyone from the public who would like to speak regarding the General Government Budget for FY2023/24. There being no additional comments, the Public Hearing was closed.

Motion made by Councilor May, seconded by Councilor Bunnell, to adjourn the meeting at 6:10 p.m. Discussion: None. Voice vote, 6-0, all in favor. Meeting adjourned.
