Town of Montville Town Council Special Meeting Minutes May 16, 2023, 7:00 p.m. Montville Town Hall – Council Chambers

- 1. Call to Order Chairman McNally called the meeting to order at 7:00 p.m.
- 2. Pledge of Allegiance
- 3. Roll Call

Present were Councilors Bunnell, Caron, Mandler, May, Rix, Yuchniuk, and McNally. Also present was Mayor Ronald McDaniel.

4. Remarks from the public relating to matters on the agenda with a three-minute limit Montville Public Schools Superintendent Laurie Pallin, who appreciated the opportunity to speak, spoke with respect to their request of \$43,799,600.00 for the FY2023/24. She stated that the requested budget increase of \$2,525,500 for the Board of Education's proposed FY2023/24 Budget includes the necessary costs to continue their current services and satisfy the critical needs in their education program, including the hiring of special education teachers, a certified athletic trainer, a Tyl Middle School P.E./Health Teacher, two (2) half-time custodians, and an Instructional Coach. There are no potential savings in employee benefits or fuel at this time. The budget does not include any excess funds for contingencies. She noted that, for the past two (2) years, the special education costs have exceeded their budget. After reviewing the budget several times, they believe that the budget, as presented, is *absolutely* required to adequately meet the needs of their students. She strongly requested their support.

Board of Education Chairman Wills Pike, an advocate and harsh critic of the BOE for several years, stated that their job, as elected officials, is to educate their students, allowing them to flourish. The largest population in the town is ages 24 to 50, traditionally the age at which families are born. Education is the fabric of the community and the education today's youth receive will benefit the growing senior community and their dedicated and supportive grandparents in the future. The BOE is seeking a 1% increase over its current budget to continue operations. During a recent Finance Standing Committee Meeting, the BOE requested half of the unexpected expense for the Tyl Middle School boiler to be included in the budget, offering to utilize part of their 2% non-lapsing account for the remaining amount. He thanked the Town Council for their consideration and time.

5. New Business

a. **Resolution #2023-52. THE TOWN OF MONTVILLE HEREBY RESOLVES** to adopt the Town's five-year capital improvement plan in the total amount of \$35,459,380.00.

Discussion: The town's ARPA (American Rescue Plan Act) Funds will be utilized to cover the costs for two (2) of the three (3) requested vehicles. Voice vote, 7-0, all in favor. Motion carried.

Motion made by Councilor May, seconded by Councilor Caron, to remove ninety thousand dollars (\$90,000.00) for Tenco Body Replacement #11 (Line Item 10960-54105) for Public Works in the Capital Improvement Plan for the 2023-24 fiscal year. Discussion: Chairman McNally stated that, due to the favorable condition of the vehicle, it was agreed to remove the item from the Capital Improvement Plan at this time. Discussion: The possibility of the project being funded by the LoCIP (Local Capital Improvement Program) Grant was noted. Mayor McDaniel emphasized the necessity of the repairs. Voice vote, 7-0, all in favor. Motion carried.

Motion made by Councilor May, seconded by Councilor Caron, to reduce MHS (Montville High School) Boiler (Line Item 10960-54009) for the Board of Education by one hundred and nine thousand dollars (\$109,000.00) in the Capital Improvement Plan for the 2023-24 fiscal year. Discussion: As previously stated by BOE Chairman Pike, half of the project will be funded by the Board of Education Budget. Voice vote, 7-0, all in favor. Motion carried.

Chairman McNally asked if there were any additional changes the Councilors would like to make to the Capital Improvement Plan. Finance Director Griffin stated that approximately \$622,000.00 in funds remain. No additional changes were requested.

Chairman McNally asked if there were any additional changes the Councilors would like to make to the General Government Budget.

Motion made by Councilor Caron, seconded by Rix, to increase Line Item 10310-51001, Mayor Salary, by twenty-five thousand dollars (\$25,000.00). Discussion: Councilor Yuchniuk felt that the item should have been introduced during a Regular Meeting to provide the public with an opportunity to speak. Councilor Caron stated that the Councilors have discussed the item on several occasions. Councilor Bunnell stated that the item was originally approved by the Town Administration/Rules & Procedures Standing Committee and, for whatever reason, was not sent to the Town Council for approval. Councilor Mandler felt that the item should have been raised during their budget discussions. Councilor Rix noted that the Chairman just provided an opportunity to the Councilors for any additional changes. Chairman McNally agreed, adding that they have just reviewed and voted on the budget line-by-line, decreasing many of the line items by minimal amounts and are still looking at a 1 mil increase. As such, he did not feel that this was the right time to approve an increase in the Mayor's salary. Roll Call vote. Voting in Favor: Councilors Bunnell, Caron, May, and Rix. Voting in Opposition: Councilors Mandler, Yuchniuk, and McNally. Motion carried.

A short recess was taken at 7:55 p.m. The meeting resumed at 8:05 p.m.

- e. Resolution #2023-56. THE TOWN OF MONTVILLE HEREBY RESOLVES to set the mill rate for the 2023-2024 fiscal year at 27.77 mills using at collection rate of 98.7%. Motion made by Councilor Rix, seconded by Councilor Mandler. Discussion: The mil rate increase is 1.06. Councilor Bunnell questioned whether the revenue received from the state was accurately calculated and expressed his concerns for the following year(s) when the impact will be more strongly felt. Chairman McNally stated that the town has passed its budget before the state's budget is set for the past several years and the town has had to base its numbers on its best guestimate. Councilor May reiterated his concerns regarding the use of their Unassigned Fund Balance and ARPA Funds for recurring costs, which will present an issue in the future. Roll Call vote, 4-3. Voting in Favor: Councilors Mandler, Rix, Yuchniuk, and McNally. Voting in Opposition: Councilors Bunnell, Caron, and May.
- **f. Resolution #2023-57. THE TOWN OF MONTVILLE HEREBY RESOLVES to** allocate Cannabis Tax Revenue to Board of Education up to an amount not to exceed \$200,000.00 (two hundred thousand dollars).

Motion made by Councilor Caron, seconded by Councilor Rix. Discussion: BOE Chairman Pike stated that the BOE plans to collaborate with the Youth Services Bureau

to educate the town's youth. Councilor May felt that the funds should also be utilized for Public Safety and the Police Departments, which are combating Cannabis daily. Mayor McDaniel added that the town is also receiving opioid funding which will be allocated toward mental health for the schools. Roll Call vote, 7-0, all in favor. Voting in Favor: Councilors Bunnell, Caron, Mandler, May, Rix, Yuchniuk, and McNally. Voting in Opposition: None. Resolution passed.

6. Remarks from the Public with a three-minute limit

BOE Chairman Wills Pike suggested providing an explanation regarding the mil rate and how it is calculated. He also expressed his appreciation for their attention to the budget.

7. Remarks from the Councilors and the Mayor

Mayor McDaniel thanked the Councilors and commended them on a great job.

Councilor Bunnell acknowledged and appreciated the hard decisions and work that goes into crafting the budget.

Councilor Caron recognized former Town Clerk Lisa Terry's presence and the BOE members. He also thanked the Finance Committee for their hard work. He stated that his decisions are based on his personal beliefs and not his affiliation.

Councilor May expressed the difficulties in serving on the Finance Standing Committee over the past four (4) years and commended Councilors Mandler and McNally for their hard work. He commented on the difficulties the town will sustain in the future due to the additional employees and recurring costs. He also expressed his concerns regarding the tax increase which will negatively affect the seniors and those in need. He commended his colleagues and felt they did a good job, but did not agree with all of the numbers.

Chairman McNally expressed his appreciation to Councilors Mandler and May for all of their hard work. He stated the difficulties they encountered while crafting the budget and acknowledged the difficulties they will encounter in the future to balance the budget.

Councilor Rix thanked the Finance Standing Committee for their hard work and efforts and their attention to detail.

Councilor Yuchniuk stated that there are no police officers, teachers, or firemen who receive a \$25,000.00 salary increase. He also stated that adding it at the end of a Special Meeting was wrong and felt that it was done so with the sole purpose of avoiding the presence of the public to express their concerns. It is, he felt, one of the reasons many do not favor politicians.

Councilor Caron disagreed, stating that the Councilors had the opportunity to express their thoughts and vote as they wished.

Councilor Mandler stated that their future is unknown. He felt that the Councilors did their very best given the numbers at hand. He thanked the Mayor and his colleagues for all of their help with the budget.

8. Adjournment

Motion made by Councilor Caron, seconded by Councilor May, to adjourn the meeting at 9:22 p.m. Discussion: None. Voice vote, 7-0, all in favor. Meeting adjourned.
