Murphy Elementary School, and authorize the issuance of general obligation bonds and notes in the amount of \$15,500,000 to finance said appropriation (with State grants to be applied for in the amount of approximately 71.07% of eligible costs of the projects, leaving the Town portion in the amount of approximately 28.93% of eligible costs plus all ineligible costs of the projects)?
