Chairman Murphy swore in Kathy Gallup, representing Professional Grounds. Ms. Gallup stated that the truck, which was rusted out and not drivable, was junked for \$500.00 on August 25, 2023. The mileage of the vehicle was provided to the Board.

Kathy Gallup, 2010 GMC Acadia

Ms. Gallup stated that, similar to the Chevy Silverado, the vehicle was not in prime condition and was recently traded in with a value of \$2,000.00.

Seth Bennett, 2003 Toyota

Chairman Murphy swore in Seth Bennett. Mr. Bennett requested a reduction in the assessed value of the vehicle based on its age, high mileage, and need for cosmetic work.

Steven Huang, 2022 Forester

Chairman Murphy swore in Steven Huang. Mr. Huang thanked the Board for hearing his appeal and wished to appeal the assessment on the vehicle due to its high mileage. The Board Members briefly stepped out of the meeting room to view the vehicle, first-hand.

Gene Chaude, 2001 Ford F-450 and 1996 Mack CH-613

Chairman Murphy swore in Gene Chaude. Mr. Chaude wished to appeal the assessment of the vehicles based on a difference in the interpretation of the state statute regarding the assessment of antique vehicles with the Assessor. He informed the Board that antique vehicles may be purchased with a cab and chassis with a body of choice installed by the dealer. Because the body differs from what is originally supplied by the manufacturer, the Assessor believed that the vehicle is disqualified for an antique exemption.

Laketa Kemp, 2019 Nissan Altima

Chairman Murphy swore in Laketa Kemp. Ms. Kemp appealed the assessed value of the vehicle based on its high mileage, the research she has conducted, the data she has accumulated, and her experience. The Board Members briefly stepped out of the meeting room to view the vehicle, first-hand.

Chairman Murphy swore in Lawrence Eiden. Mr. Eiden requested that the vehicle be considered for an antique vehicle exemption.
