Proposed Zoning Regulation Amendment to add Section 21B "Prohibition of Retail Cannabis Establishments"

Applicant: Town of Montville Planning and Zoning Commission

SECTION 21B Prohibition of Retail Cannabis Establishments

21B.1 Purpose.

The purpose of this regulation is to prohibit specific retail cannabis establishments in the Town of Montville.

21B.2 Definitions.

- **A.** Cannabis. Marijuana as defined in Section 21a-240 of the Connecticut General Statutes.
- **B.** Retail Cannabis Establishment. A dispensary facility, retailer or hybrid retailer, as set forth in Connecticut General Statutes Section 21A-420, as may be amended.

21.B.3 Prohibition of Retail Cannabis Establishments.

- 1. No building or premises in the Town of Montville shall be used for a retail cannabis establishment.
- 2. Any existing permitted retail cannabis establishment, legally established and operating prior to the effective date of this regulation, may continue to operate in its existing approved location. Ancillary facilities necessary for the continued safe operation of the facility may be expanded, upgraded and/or improved, however, the gross floor area or building footprint shall not be expanded. The installation of drive through service is prohibited.
