The oral board examination portion of the selection process for an entry level position as police officer, Town of Montville, was conducted on May 10, 11, and May 12, 2010. A total of fourteen applicants were interviewed using the protocol in place.

The Oral Board Panel consisted of Montville Lieutenant L. Bunnell, Resident State Trooper Sergeant M. Collins, Montville Detective T. Occhialini, Public Safety Commissioners G. Allyn, M. Interviews on May 12, 2010 began at 2:00 p.m., with five applicants being interviewed. The interview process concluded at approximately 5:10 p.m..
