Project Descriptions:

- 1. Public Works Office Upgrades 2024 Project for improvements and upgrades at the Public Works Office, including, but not limited to, the removal of asbestos in the basement and conversion to usable space, repairs to exterior/interior wall that has water and termite damage, replacement of windows, repairs or replacement of the concrete porch at entrance to building, and the installation of a new furnace.
- 2. Town Hall Improvements 2024 Project for improvements to the Town Hall, including, but not limited to, the repair or replacement of the roof, repointing and sealing brickwork, painting, removal of an underground oil tank, boiler replacement and HVAC improvements.
- 3. Senior Center Boiler 2024 Project for the replacement of the boiler in the Senior Center Building.
- 4. *Palmer School Roof Replacement 2024 Project* for the roof replacement at Palmer School located in the Town, including sky lights, downspouts and any other appurtenances or work related thereto.
- 5. Bus Garage Tank Replacement 2024 Project for the replacement of the fuel tank at the Bus Garage located in the Town.
