# TOWN OF MONTVILLE MEETING OF BOARD OF EDUCATION MONTVILLE HIGH SCHOOL LIBRARY/MEDIA CENTER May 18, 2010 at 6:00 p.m.

#### Item 1. Call to order.

# Item 6. Report from Student Board Representatives.

Student Board Representatives Jake Alexander and Jessica Semmelrock gave a report to the Board as follows:

- 1. This morning the Social Studies Department hosted a voter registration drive for students aged 18 or older.
- 2. The MHS International Club and Montville Arts Café will host an Evening of Arts on Culture on May 20 from 6-8 p.m. showcasing MHS' diverse cultures and talents. The Board is invited to attend. The Café has also been hosting a successful book drive for the past two weeks.
- 3. MHS' literary magazine, *Images*, has been awarded the distinction of "excellence" by the National Council of Teachers of English for last year's magazine.
- 4. Julia Berry won honorable mention at the Congressional Art Competition on April 30, and her work is being displayed in State Representative Joe Courtney's office. She was also recognized by the Connecticut Association of Schools as MHS' top art student and her work will be displayed along with other student projects in the MHS Library/Media Center on June 1 from 2:30-4:30 p.m.
- 5. Todd Johnstone, a survivor of the Albatross wreck and whose notes were the basis for the movie "White Squall," will visit the Maritime class as a piece of their oral history projects.
- 6. Seventy students from chemistry and physics classes held a Rube Goldberg event on April 28 to create, design, and build a device that employed twelve energy transformations, three of them chemical, to perform a simple task, such as turning on lights or blowing out a candle.
- 7. The girls track team won their third consecutive ECC Medium Division Championship with a dual meet season record of 6-1 and 5-0 in the medium division. Montville will host the ECC Track Championship for the first time, Saturday, May 22 at 10:00 a.m. The varsity baseball team clinched a tie for division champs today having won five straight division titles. Girls tennis is currently at 5-6 and Boys tennis has a record of 2-9.
- 8. Over \$800 was raised this year by the physical education/health department at the annual Hoops for Heart Fundraiser to benefit the American Heart Association.
- 9. As a fundraiser, the Class of 2011 hosted a Game Night at Murphy School with over 25 elementary students in attendance. The junior class is planning a spaghetti dinner and a car wash before the end of the year.
- 10. The Botany class held an annual Mother's Day plant sale.
- 11. In Advisory on May 19, seniors will present their Senior Projects to the junior class as encouragement for pursuing their own passions.
- 12. The teachers of Business, Life Management and Technology Education met with a representative of the State Department to discuss the Perkins Compliance Grant review.
- 13. The Music Department will host its end of the year concerts in the upcoming weeksthe final Choral Concert will be on June 3 at 7:00 p.m.; the senior choral students will hold their concert on June 1; and the final band concert featuring the concert, jazz, and percussion ensembles will be on June 8. The Music Department took music students on a trip to the Rhode Island Philharmonic Symphony on May 7.
- 14. More than 75 students will be inducted into the National Honor Society and National Foreign Language Honor Society in the MHS auditorium on May 19, at 7:00 p.m.

- 15. Students who made the third quarter honor roll will be honored at a luncheon on May 25.
- 16. Final exams for seniors will begin on June 1 and for underclassmen on June 15.
- 17. The underclassmen award ceremony will be held on May 27 at 7:00 p.m. and the senior awards ceremony on June 7 at 7:00 p.m. The Board is invited to attend.
- 18. Senior Outing will be on June 4 at High Meadows in Granby, CT. Senior Prom is June 12 at 7:00 p.m. at the Mystic Marriott. Board members should receive invitations within the next week or so.
- 19. Graduation is on June 17 at 6:00 p.m. on the MHS athletic field.

#### Item 7. Unfinished business.

# a. Review 2010-2011 budget development to date.

P. Aubin reported that she had a meeting with the Board of Finance. Other meetings are scheduled for Monday, May 24 at 4:00 p.m. and Wednesday, May 26, when the Board will learn about its 2010-2011 budget.

# b. Discussion of Artificial Turf Study.

B. Levesque discussed the final report regarding the study of artificial turf. He said the district has met with the preparers of the report and the results were mostly positive. A final report is pending.

# c. Discussion/update of Federal Race to the Top (TRRR), Phase II Program.

P. Aubin on status of Race to the Top that has the support of statewide education associations enabling legislature to be passed by the State. Area Superintendents have agreed to work together and support the initiative that will meet the changing requirements for a Title I district. She also reported that NCLB would revert back to its former name, Elementary Secondary Education Act (ESEA).

#### **Item 8. New Business**

a. It is recommended that the Board of Education review/approve changes to Policy 2131, Superintendent of Schools.

# b. Apprisal of Teacher Education and Mentoring (TEAM) Program Plan for Beginning Teachers and Mentors.

B. Levesque reported that he is the district administrator for TEAM, formerly known as the BEST mentoring program for new teachers. He thanked the Committee for their hard work regarding the same that should comply with the State plan once it is approved. The district plan will be part of the regular review process and will be in place for new teachers. Six meetings are committed for the year.

- c. It is recommended that the Board of Education comply with Public Act 06-63, an act concerning Healthy Foods & Beverages in School for the 2010-2011 school year. The Montville Board of Education elects, for the 2010-2011 school year, to permit the sale of all foods and beverages that are not legally permitted during the regular school day if the following conditions are met:
  - 1. The sale of foods and beverages in connection with an *event* occurring *after* the end of the regular school day or on the weekend.
  - 2. The sale of foods and beverages is at the location of the event.
  - 3. The foods and beverages are not sold from a vending machine or school store.
- B. Levesque reported that the plan has to be updated annually.

B. Mitchell reported that the Committee met on May 11 and had an informational session.

#### c. Montville Education Foundation (Deborah Reed-Iler).

D. Reed-Iler reported that the MEF had its first annual art show on Saturday, May 14, but the event was not well attended due to great weather that day. The annual golf tournament will be held on July 12 and items are being solicited for gift baskets.

# d. LEARN (Deborah Reed-Iler).

D. Reed-Iler reported that she could not attend the last meeting as she could not get the time off from work. She said she would be attending the next LEARN meeting when the director's evaluation will take place.

# e. CABE/NSBA (Robert Mitchell).

B. Mitchell reported that, for the second year in a row, CABE will not increase its dues. He also said that preparations are in the works for the CABE Convention in November at the Mystic Marriott. The NSBA will hold its next convention in San Francisco.

#### f. School Building Committee (Todd Pomazon/Carrie Baxter).

T. Pomazon reported the Committee will meet tomorrow, May 19, and will discuss the promenade tile issue at the high school. P. Aubin or B. Levesque will attend.

# g. MetroCast Communications Advisory Council (Tom McNally).

T. McNally reported that the next meeting is Thursday, May 20 at 5:30 p.m.

#### h. Capital Improvement Committee (Tom McNally).

At the March Board meeting, T. McNally reported that the Committee will not meet this year but will be reinstated next year. This item will remain on the agenda.

# i. Montville Youth Services Bureau (Robert Mitchell).

B. Mitchell reported that the Bureau had a successful spaghetti dinner a few weeks ago. He also reported that level funding is expected from the Town. Also, the summer program is fully booked.

#### k. Chair's Remarks.

D. Rowley reported that he gave a tour of the district to the Superintendent and Board Chair of Region 16. He also attended three schools and had lunch at the high school on Staff Appreciation Day. Also, he and B. Levesque attended the program regarding Carl Wilkins. D. Rowley also attended three Board of Finance meetings and he and B. Levesque did a program on Cable Access Channel 22. At Mohegan School, he read to a third grade class.

# Item 10. Superintendent's Report.

# a. Report from the Director of Student Services – Ms. Maynard.

D. Maynard reported that two new hires will move the department in the right direction. She is also working to clean up data for IEPs that will need to be sent to the State. D. Maynard also reported that she is finalizing the summer school staff and student list that has a high number of Tyl students.

#### b. Report from Assistant Superintendent – Mr. Levesque.

B. Levesque reported that Joel Farrior will travel in Rwanda with Carl Wilkins this summer. He also read *Revenge of Rupelstiltskin* to a grade four class at Murphy School. A new Speech/Language Pathologist has been hired with a savings to the district. Hiring is ongoing for a science position at MHS and resumes are coming in for the Special Education Program Manager position. Also, the Committee for Student Management is still looking at programs for student data resources.

# c. Monthly Update.

P. Aubin reported per data from the State Department of Education that Mohegan may be leaning toward being off balance. She also said that B. Levesque is leading the district improvement plan in addition to Race to the Top for which subcommittees and an action plan is being prepared to focus on priorities. P. Aubin also reported that she is finalizing Instructional Rounds with administrators with an upcoming meeting at Palmer Academy. She said that she would be participating in Instructional Rounds in Bethany and Woodbridge to identify and formulate an action plan to deal with issues witnessed by administrators' visits to classrooms. P. Aubin also commented that she has now spent a full day in each of the district school including touring the grounds. She also reported on her attendance at the NCERT Conference that dealt with technology and educational research with the same.

P. Aubin also reported that she attended some Staff Appreciation Day events and thanked all staff and volunteers who took part. Also, Title I communication was discussed at Parent Advisory. She also judged a public speaking event at Tyl between middle school students from Woodstock. She also participated in Read Aloud Day and read to a grade 5 classroom. In conclusion, P. Aubin reported that the Perkins Grant review took place today.
