MEETING MINUTES

1. Call to order.

Vice-Chair Stewart called the meeting to order at 6:03 p.m.

2. Pledge of Allegiance.

All stood and pledged the flag.

3. Roll Call.

Present were Vice-Chair Stephen Stewart and Commissioners Brian Baker, William Bauer, Mickey Gillette and Karen Perkins. Chairperson Murphy and Commissioner Tracy Callaghan were absent from the meeting. A quorum was present.

- 5. Special Recognitions and Presentations. -- None

6. Communications:

Copies of monthly statistics reports from Fire Departments, Fire Marshal, Police Department, Animal Control and Building Official.

Vice-Chair Stewart reported on having received the monthly statistical reports for Oakdale and Chesterfield fire companies; but not from Mohegan or Montville which Commissioner Perkins confirmed she did not receive. The reports from the Fire Marshal, Police Department, Animal Control and Building Department were received by the Commission.

7. To Consider and Act on a Motion to approve minutes:

a. The Regular Meeting Minutes of January 27, 2025.

Chair Stewart noted a correction on Pg. 2 concerning the motion in the amount of \$78,4000 for the "FY2025-2026 Public Safety Building Budget." Voice vote: 5-0-0, all in favor. Motion carried. (The amendment was approved with existing motion on the floor.)

9. Remarks from Department Heads.

Police Department Report

Lt. Radford read into the record the Animal Control reports for the month ending January 31, 2024. See Agenda Item 10.B for those statistics. The Lieutenant also reported on having applied again for the High Risk Rural Roads Speed Enforcement Grant that was approved in the amount of \$49.115.72. Four (4) pieces of equipment, radar units, were purchased at approximately \$3,600 each totaling \$14,000. This is the second year that the Department has taken part in this effort. Due to its stats from last year's grant, 877 traffic stops in the 3-month period March 1 – May 30., a press conference will be held by the State DOT recognizing the efforts of the Department as one of the top enforcers. The press conference will be Wednesday, February 26, 2025 at 11:00 a.m. at the Public Safety Building.

12. Unfinished Business.

a. To Consider and Act on a Motion to Approve a Policy to systemize and retain firefighter data to observe trends and effectiveness.

Vice-Chair Stewart asked if there were any updates; Commissioner Perkins reported that Mayor Bunnell was waiting for information from the fire chiefs. The Vice-Chair added that a decision is still pending on the software for reporting.

b. Fire Companies Radio System Upgrades. (Baker)

Commissioner Baker deferred to Lt. Radford for an update on the radio system project. Lt. Radford reported that he spoke with Comms Plus at the end of last week They have the State IDS, and everything needed for Dispatch but are awaiting another key in a couple of weeks. By mid-March, Dispatch should be up and running.

13. New Business.

a. To Consider and Act on a Motion to Approve the FY2025-2026 Fire Department Capital Improvement Plan.

Vice-Chair Stewart noted that the Fire Department Capital Improvement Plan (CIP) was not available for the Commission Special Meeting concerning the FY2025-2026 budgets on February 6. Commissioner Baker reported having reviewed the CIP and spoken with three (3) of the fire chiefs and with Chief Platt of the Mohegan Fire Company in the absence of Chief Suarez on an item relevant to that company. Commissioner Baker noted a change to the heading of the CIP to Montville Fire Companies Capital Improvement Plan as it is not a fire department. He referred to an item written as Forsetry although pronounced by Commissioner Baker as Forestry M-24 (Town/FEMA). Commissioner Baker confirmed with Chief Platt that the Mohegan Fire Company supplemented funds for this purchase as the grant received by the Town did not take care of everything that was needed/wanted for the truck. Additionally, the Town owns the M-24 and maintains it. Therefore, as to the replacement schedule going forward the ownness is on the Town and should be removed from the CIP. Further, he proposed removing the Forsetry M-34 Town that is owned by Chesterfield to the company owned area of the list. As to the Rescue M-47 (Town/State) this item is currently State owned and will be turned over to the Town in the near future and per Chief Messer it is classified as a rescue although it is not. The M-47 will be retitled as Special Operations as it can do a multitude of tasks on the fire scene i.e., a fire mover as questioned by Commissioner Perkins. Oakdale will take care of that. At the bottom of the CIP, Commissioner Baker noted that there a list of numbers multiplied by 1000 for replacement purposes for upcoming years. He will request feedback from the Finance Department as to whether an account will be created for the purpose of replacement vehicles and other apparatus requested by the fire companies as it has not been done by the Town over the past years. If it will not be funded, should it be taken out of the CIP. Commissioner Baker asked that the motion be tabled until the corrections to the CIP have been made. He will reach out to the keeper of the plan, Chief Turner, and to Finance for clarity as mentioned.

Motion by Vice-Chair Stewart; seconded by Commissioner Baker to table approval of the Montville Fire Companies' FY2025-2026 Capital Improvement Plan to the March Commission meeting. Discussion: none. **Roll Call vote:** *In favor:* Commissioners Perkins, Bauer, Stewart, and Baker. *Opposed:* Commissioner Gillette. **4-1-0**, **all in favor. Motion carried.**

14. Remarks from the Public. (three-minute limit. -- None

15. Remarks from the Mayor.

Commissioner Baker remarked that he believed that Mayor Bunnell was absent from the meeting in order to attend the Board of Education budget presentation.

16. Remarks from Town Council Liaison.

17. Remarks from Commissioners.

Commissioner Perkins thanked the Police Department and Fire Companies for everything they are doing. Vice-Chair Stewart remarked that all be safe and invited anyone who is available to attend the upcoming Police Department press conference.

Motion by Commissioner Baker; seconded by Commissioner Gillette to adjourn the meeting at 6:27 p.m. Discussion: none. **Voice vote: 5-0-0, all in favor. Meeting adjourned.**
