Item 2. Discussion of the superintendent's proposed operating budget for 2025-2026

Board members' discussion focused on review and clarification on Budget Summaries: Object 116 Special Education, Object 117 Instructional Coaches, Object 130 grant, Object 410 Electricity, Object 425 – Library Services, Object 540- Telephone cost, Object 541 – mailing, Object 611 – Supplies for Instruction, Object 616 – Sports supplies, Object 641 – text books, Object 643 – Library Periodicals.

Discussed Pre – School option 3. Supports 5 days a week instruction from 9:00-1:00, as it stands would save 6K this is due to reduced busing cost.

Discussed the cost of new servers. (Nic Savoie)

Discussed the cost to upgrade to a new financial system, which would include access to an employee portal. (Cloud Based), when could we implement this new system?

Superintendent Vumback spoke to her recommendations for the budget including an ML Teacher, our AD requested a freshman Volleyball Coach, the need for an HR Director at Central Office, it consumes more time than I ever expected it to, most districts have a dedicated HR Director, this would go a long way of modernizing our district. What is the estimated salary for this position, DV – ranges from \$90K-150K, depending on how we fill the position. Lisa Terry: Is this a service that we could share with the Town? DV: I never

considered that. Wills Pike: I like this idea very much; most districts have many more layers of staff. Freshman Volleyball coach seems like a no-brainer to me. Tina: I have a great deal of respect for HR People. Superintendent Vumback: We are relying on the attorneys for a lot. Bonnie Bacon: If you had an HR director would it save money on attorney fees? Yes, long-term it would but initially we would still be using the attorneys to ensure that things like our contracts align.
