- 1. <u>Call to Order</u> Chairperson Jacobson called the meeting to order at 7:06 PM.
- 2. Pledge of Allegiance
- 3. <u>Roll Call</u> Present were Councilors Beetham, Buebendorf, Caron, Hillman, Jacobson, McFee and Murphy. Also present were Mayor Jaskiewicz and Finance Director Terry Fafard.

4. Remarks from the Public

Mr. Dick Wilson, 6 Riched Lane, stated that he has reviewed a few different copies of the proposed budget, including the Mayor's proposed budget published in April and a recent version prepared by the Chairwoman, and he suggests that the Council consider the Chair's version as it puts the Mill Rate 22.39, which is in line with the Mill Rate of 22.4 adopted by the Council.

Lt. Leonard Bunnell, Montville Police Department, urged the Council to support fully staffing the department with 23 officers. Lt. Bunnell referenced a letter sent to the Council from Chairman Jetmore, Public Safety Commission, requesting the Council's support in maintaining a full staff of 23 officers. Lt. Bunnell stated that if the Department does not send officers to the academy this year as planned, they will be penalized and lose the spots, leaving the Department understaffed, possibly for a couple of years. He reported that calls of service continue to increase, and will continue to increase, and having less than 23 officers in the Department puts the public in jeopardy.
