AN ORDINANCE REGARDING THE CONVEYANCE OF REAL PROPERTY LOCATED AT 14 AND 22 BRIDGE STREET

THE TOWN OF MONTVILLE HEREBY ORDAINS: Section 1.

The Finance Director of the Town of Montville is hereby authorized to conduct requests for proposals for the sale or lease of certain real property located at 14 and 22 Bridge Street, Montville, Connecticut containing approximately 1.07 and .46 acres, respectively, being premises conveyed to the Town of Montville by deed recorded in Volume 566, Page 748 of the Town of Montville land records. Said request shall be conducted by a broker and/or by sealed bid or auction at the Finance Director's discretion, and shall be sold or leased by the Finance Director to the highest and best acceptable proposal, subject to the terms and provisions herein and as determined by the Finance Director, the Town Attorney and the Mayor, in their discretion. The Finance Director shall prepare request specifications, which shall include the terms and conditions of the sale or lease and shall have the right to reject any and all proposals and to waive any irregularity or informality with respect to any bid.

Section 2.

Upon acceptance of a request by the Finance Director, the Mayor is hereby authorized to execute, and the Town Clerk to attest to and affix the seal of the Town of Montville to, a quit claim deed or lease of the premises known as Assessors Parcels 082-079-000 and 082-081-000 after approval by the Town Attorney as to form, terms, content and legality to the real property described herein.

Section 3.

The Mayor is hereby authorized to include such other terms, conditions, easements and restrictions in the deed as he and the Town Attorney deem to be in the best interests of the Town of Montville.

Section 4.

This ordinance shall become effective thirty (30) days from the date of its adoption.
