The Montville Police Department has the following comments and or concerns with the review of PTA Lane.

1. This will increase traffic flow on Golden Road, which is narrow and make an already difficult intersection (Rte 32 and Golden Rd) even more difficult to maneuver.
2. There will obviously be a cost to the town, if even possible, to upgrade Golden Road for the safety of the motoring public.
3. The school busses use PTA Lane daily, which is a much wider and less traveled road to help with safety of the children. I witness the busses on PTA Lane daily. In fact I passed 4 busses on PTA Lane, as I was responding to a call at the school.
4. PTA Lane is also used by parents for drop off and pick up purposes, again rerouting more traffic to Golden Rd.
