Re: Lease dated May 11, 2005, as amended (the "*Lease*") currently between Montville Station LLC (the "*Landlord*") and The Stop & Shop Supermarket Company LLC ("*Stop & Shop*") for premises located at Route 32 South, Montville, CT 06050 (the "*Shopping Center*") Store No. 678 (the "*Store*")

Dear Landlord:

Stop & Shop is pleased to introduce its relationship with Clynk, which will allow us to provide a convenient way for our customers and other users of the Shopping Center to return their redeemable bottles and receive a refund of their bottle deposit.

By this letter, Stop & Shop is requesting Landlord's consent to the installation in the Shopping Center of one of Clynk's Sustainability Stations, a prefabricated structure that does not require external utilities. Attached as Exhibit A is (i) a prototype of a model Sustainability Station and accessory structures necessary for the operation thereof and (ii) the specifications for the Sustainability Station to be installed at the Store (collectively, the "*Redemption Station*"). Stop & Shop agrees to be responsible for all necessary permits as well as all costs required for the installation of the Redemption Station.

The Redemption Station will be installed in the location (highlighted in green) as shown on the attached Exhibit B (the "*Location*"). Additional information about Clynk and the Redemption Station proposed for the Shopping Center are also attached as Exhibit C.

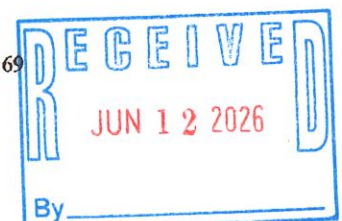

IMAGE AND SPECIFICATIONS OF TYPICAL REDEMPTION STATION



Placement of an 8' x 32' CLYNK Sustainability Station in the parking lot, requiring the use of 5 parking stalls.

This is an unmanned, pre-fabricated unit used for the collection of redeemable bottles and cans via Bag Drop.

Station operates on solar and wind power generation, which requires unobstructed southern exposure, it is portable, with a gross weight of ~3,200 pounds.

Station is placed and shimmed on existing parking surface. No sitework or utilities required.
