SPECIAL MEETING MINUTES 7:00 P.M. May 3, 2012 LOCATION: MONTVILLE TOWN HALL, Council Chambers

- **1. Call to order:** Chairman Brush call the Inland Wetlands Special Meeting to order at 7:04 pm in the Town Council Chambers.

Commissioner Brush opened the public hearing at 7:04 p.m. Chairman Brush read the following legal notice published in the New London Day into record:
