Town of Montville Water Pollution Control Authority

**Resolution** regarding the usage charges for the use of the public sanitary collection sewer system in the Town of Montville, Connecticut established the amount of such charges and providing for the payment of same.

Whereas, the Town of Montville Water Pollution Control Authority, the statutory municipal authority existing under the law of the State of Connecticut and within and for the Town of Montville, has therefore set usage charges for the sanitary sewer system; and

Whereas, the Connecticut General statutes provide in part that the Town of Montville Water Pollution Control Authority may establish and revise a fair and reasonable charge for the use of the sanitary sewer system;

Now therefore be it resolved **SAR-\_\_\_\_**by the Town of Montville Water Pollution Control Authority as follows:

- Un-metered account users- the rate for each unit shall decrease from \$88.00 per quarter to \$80.00 per quarter. The said rate decease shall commence with the first billing after the adoption of this resolution, October 1, 2016 for use during the period of July 1, 2016 through September 30, 2016 and continue quarterly thereafter until such time as the rate herein may be revised or altered.
- 2. Metered account users- the rate charged for metered accounts shall decrease from \$5.474 per thousand (1000) gallons to \$4.981 per thousand (1000) gallons. That said decreased rate shall commence with the first billing after adoption of the resolution, October 1, 2016 for the use during the period of July 1, 2016 through September 30, 2016 and continue quarterly thereafter until such time as the rate herein may be revised or altered. Regarding users billed monthly rather than quarterly, the foregoing rate decrease shall commence with the first billing after the adoption of the resolution, August 1, 2016.
- 3. Users in excess of domestic strength sewage (Rand-Whitney Containerboard and Mohegan Sun) the rate decreases in Flow from \$2.063 per thousand gallons to \$1.877 per thousand gallons (1000), BOD decrease from \$0.367 per pound to \$0.334 per pound and TSS from \$1.005 per pound to \$0.905 per pound. The foregoing rate decrease shall commence with the first billing after the resolution, August 1, 2016.
