Minutes –September 6, 2017

1. Call to order

Chair Doherty-Peck called the meeting to order at 9:02 a.m. on September 6, 2017 in the library at the Senior Center.

2. Roll call

a. Doherty-Peck reported that she has received award letters for four grants written: \$75,150.00, \$16,400.00, \$9,500.00, and \$11,232.00, totaling \$112, 282.00.

b. Last fiscal year, Doherty-Peck stated that she, along with the help of dedicated staff and volunteers, was able to bring in \$178,000.00 for programs and services.

c. Doherty-Peck is looking for additional grant opportunities to be able to add additional classes to schedule. As programs are offered for free to seniors, funds are needed to add.

d. All went very well at Center over summertime and looking forward to the remainder of the year's programs.

e. Doherty-Peck stated that according to the CT State Plan on Aging, by 2025, 1 in 5 residents in the state of CT will be over the age of 65. This is important as the services needed will grow with this growing population and we should work on ways to educate the public and local officials of our future needs.

a. Liaison Caron reported that the Council passed a budget though hesitant to do so without the State passing a budget. There is talk of additional cuts to the Town and the School system and those will be addressed.

b. Liaison Caron reported that he plans to continue to fight for what the Town should be getting with some of the proposed cuts.

c. Liaison Caron discussed the grant recently received by the Town to address needed changes at the Transfer Station.

d. Liaison Caron opened discussion with members on varies Town issues.

a. Skinner suggested that the patio area outside of the dining hall be utilized. Liaison Caron stated he would speak to the Public Works Director about getting the roof for the area.
