- b. Consideration and action to comply with Public Act 06-83, an act concerning Healthy Foods & Beverages in School for the 2017-2018 school year by modifying the March 21, 2017 vote which passed to comply with the Healthy Foods and Beverage for the 17-18 school year.

The Montville Board of Education elects, for the 2017-2018 school year, to permit the sale of all foods and beverages that are not legally permitted during the regular school day if the following conditions are met:

- 1) The sale of foods and beverages is in connection with an *event* occurring *after the end of the regular school day or on the weekend*.
- 2) The sale of foods and beverages is at the *location of the event*.
- 3) The foods and beverages are *not sold from a vending machine or school store*.

An “event” is an occurrence that involves more than just a regularly scheduled practice, meeting, or extracurricular activity. For example, soccer games, school plays, and interscholastic debates are events but soccer practices, play rehearsals, and debate team meetings are not. The “regular school day” is the period from midnight before to 30 minutes after the end of the official school day. “Location” means where the event is being held.
