Superintendent Levesque advised that all four bids received were over the \$480,000 which was already appropriated. The only way to complete this project is to appropriate the anticipated overage of \$90,000. We contacted the State and they indicated that they will still honor the re-imbursement rate of 68%. Bob Deluca, the engineer for the Town, explained how the cost of the project changed so dramatically and the assumptions which were made which caused this, the scope of work did not change. There were many unknowns with the project which caused his estimate to come in too low. The State recommended the \$90,000 as a safe number.

This new number is good because it is based on the actual bids received. There is a 20% contingency built into this number and we are hopeful that not all of this money will be used but will be returned to the non-lapsing account. This project solves all of the water problems at both Tyl, the bus garage and the high school.

# Item 5. Presentation/discussion on the Superintendent's proposed budget for 2018-2019.

Superintendent Levesque presented three budget scenarios and emphasized that scenario one, which was built off of the 2017-2018 budget which was originally funded by the Town of Montville, is the one which he supports. It is his belief that based on the information regarding the funding of ECS money that the State will again cut ECS funding to Montville and the board will likely be faced with difficult decisions once again this spring. The intention of providing three budget scenarios was to provide The Board with the time necessary to consider all of the options when facing possible cuts. The presentation may be found in its entirety on the district web site under the 2018-2019 budget.

Board Comments; Sandra Berardy; As a Board Member it is my responsibility to keep programs and I don't want to keep hacking away. We need to think of where we should be, what we should be adding and how will we come up with more money. We need to fight for that and do what's right for the school system first. Looking at a bottom line number does hurt kids. Twenty-five students in a class should be examined and revised. Monica Pomazon; Wants to work to find a balance between some cuts and trying to keep what we have. Chair Bob Mitchell; I am proud of what we have and the achievement of our students. I'd love to bring back what we have lost, like Spanish at the Elementary

Schools. Our next meeting is February 21<sup>st</sup> where we will take public comment and consider options. Dan Boisvert; agrees with the comments made by Sandra. Chair Bob Mitchell asked the remaining board members if they had additional comments, there were none.
