The following Ordinance, copies of which may be obtained at the office of the Town Clerk during office hours, was introduced at a regular meeting of the Town Council held September 10, 2018 and a public hearing thereon and for its consideration by the Town Council will be held at Town Hall Council Chambers, October 10, 2018 at 6:45 P.M.

AN ORDINANCE REGARDING THE CONVEYANCE OF REAL  
PROPERTY LOCATED AT 916 Route 163

THE TOWN OF MONTVILLE HEREBY ORDAINS:

Section 1.

The Tax Collector or the Finance Director of the Town of Montville is hereby authorized to conduct bidding for certain real property located at 916 Route 163, Oakdale, Connecticut containing .42 acres being the same premises conveyed to the Town of Montville by deed dated August 10, 2017, and recorded in volume 628, page 244 of the Town of Montville land records. Said bidding shall be conducted by sealed bid or auction at the Finance Director's discretion and shall be sold by the Finance Director to the highest acceptable bidder subject to the terms and provisions herein. The Finance Director shall prepare bid specifications which shall include the terms and conditions of the sale and shall have the right to reject any and all bids and to waive any irregularity or informality with respect to any bid.

Section 2.

Upon acceptance of a bid by the Finance Director, the Mayor is hereby authorized to execute, and the Town Clerk to attest to and affix the seal of the Town of Montville to, a quit claim deed known as the premises located at Assessors Map 46, Lot 5 after approval by the Town Attorney as to form, content and legality to the real property described herein.

Section 3.

The Mayor is hereby authorized to include such other terms, conditions, easements and restrictions in the deed as he deems to be in the best interests of the Town of Montville.

Section 4.

This ordinance shall become effective thirty (30) days from the date of its adoption.
