 - a.) Hastedt Brothers LLC/Lombardi Business Park, LLC: An application for a Special Permit for a mobile asphalt recycler located on the property at 18 Sachatello Industrial Drive, Oakdale, CT. As shown on Assessor's Map 5 Lots 27-10 and 27-17 and a portion of Lots 18, 11, and 13. The Chairman opened the Public Hearing at 7:02 p.m. **STAFF:** Staff entered the following into the record: Exhibit 1. Certified Mailing Receipts. Exhibit 2. Copy of the legal ad as published in the New London Day. Exhibit 3. Staff Report. Exhibit 4. The entire application including maps/plans. Staff report was distributed to the Commission and read. APPLICANT: Ellen Bartlett, 317 Main Street, Norwich Staff explained the re-configuration of the property that previously took place. Attorney Londregan of Conway, Londregan, et al of New London, Ct., applicant's attorney addressed the Commission and entered the following into the record as Exhibit 5.; recycling asphalt info, DEP General Report dated 3/13/09, DEP Inspection report dated 6-2-09, §22a-174-3a of the Regulations of Connecticut State Agencies. Attorney Londregan provided the Commission with an explanation of how the machinery works. Maps of the area showing the proposed location were shown to the Commission and entered into the record as Exhibit 7. Overall Plan, Exhibit 8. Lot Layout and Exhibit 9. to address the Commission's concerns. Andy Hastedt addressed the Commission's concerns regarding dust and cleaning of the machinery and told them that the machinery is self-cleaning. Opposed: none. **APPLICANT:** Attorney Londregan reminded the Commission that they are not making bituminous concrete, they are recycling and this is simply a machine on a trailer. Voice vote. 7-0 All in favor. **MOTION CARRIED.** The Public Hearing closed at 7:38 p.m.
