Councilor Jaskiewicz called the meeting to order at 5:00 PM. Present were Councilor Rogulski and Councilor May and Finance Director Hart.

Remarks from the public - None

Councilor May moved, second by Councilor Rogulski, to approve the minutes of the 12/29/20 meeting. Motion passed.

The Committee discussed the 2021-22 Department Budget Requests. Hart explained that the State has proposed revenue for distressed communities. It is not clear at this time if there will be restrictions on how this money can be spent. It is not anticipated that this will be recurring revenue. The Committee felt that this is best used for one-time or capital expenditures.

The Committee reviewed the expenditure line items. Hart will follow up on the expenses for the Community Booklet, which are down this year. There was discussion regarding part-time help in the Central Service Budget. The committee would also like a history for the lease of equipment and office supplies lines. The committee asked about expenses for Quality Data/Computer Services in the Finance budget. Hart explained that some updates for the Payroll Program have been delayed because of Covid-19. The IT Director has made a request for part-time clerical help. The Committee discussed if having a floating secretary for the Town Hall would be a better option.

The Town will be receiving funds from the America Rescue Plan. There may be some expenses that can be paid with these funds such as the increase in the poll workers line, medical insurance and building improvements related to Covid-19.

Hart explained that she will requesting the Town Council establish a special fund for money from the American Rescue Plan. The Town will have until the end of the 2024 calendar year to use these funds.

Remarks from the Public-Alfred Mandler submitted questions regarding the amount budgeted for the Blight Officer and the increase for Public Safety budgets vs the Board of Education budget. Hart will gather this information.

Meeting was adjourned at 6:05 PM.
