Deputy Chair Caron introduced Board of Education Chairperson Sandra Berardy and Superintendent of Schools Laurie Pallin who spoke on behalf of the proposed FY 2020-2021 Education Budget.

BOE Chairperson Berardy stated it is the same as every year (referring to her name and address) and said it is another year for their budget and as usual the BOE had several meetings to set the budget right and come up with an accurate one for review. The number of grants received by the Board of Education this year caused some confusion with the thinking that they may offset the normal BOE budget. Those grants are streamlined for individual programs and do not offset what would be presented in the normal BOE budget which Superintendent Pallin will explain. This year there was a meeting with the subcommittee of the Board of Ed and the subcommittee of the Finance Committee to clear up questions they had. The numbers of the Mayor's budget look good and we hope they will remain as he proposes.

Superintendent of Schools Pallin expressed appreciation for Mayor McDaniel's proposal to fully fund the Board of Education operating budget. Steps in preparation of the budget included determining next year's cost without additional services and all possible reductions, specifically contractual salary increases, estimated benefit increases, purchased services, and supplies; in addition to, savings due to eight (8) teacher retirements and resignations and an estimated decrease of out-ofdistrict transportation costs. The increase of \$465, 405 in the 2022 budget over the 2021 budget was based upon student enrollment and student learning needs. Funding from the Esser Grant, instead of the operating budget, to be used for replacement of part-time paraprofessionals to full- time, an ELE coach, and teacher leaders and a full-time SRO at Tyl. Over a period of time, the BOE scrutinized and reduced the budget including pandemic related measures such as replacement and lease of technology for distanced learning, to pay for CIP requests for 2022 reduced from \$2 million to \$1,295,157.00, and to reduce salaries and benefits for bus drivers. The FY 2021-2022 BOE request is for an increase \$554,336 or 1.3%, from their FY 2020-2021 budget, totaling \$39,816.40. Superintendent Pallin highlighted the Esser Grant as a means to accelerate and support student learning and accommodate the loss of academic skills as a result of the pandemic. She thanked Business Manager Kathy Lamoureux for her work in preparing the budget and welcomed questions.

Deputy Chair Caron asked three (3) times if there was anyone from the public who wished to speak regarding the Board of Education Budget for FY 2021-2022.

Board of Education Member Pike, 79 Pheasant Run, Oakdale stated he understood both sides of the Board's budget as a former Town Councilor and now as a Board of Ed member and spoke of credibility, responsibility, effort in the process, and his having been a financial critic for years under three (3) former superintendents. He spoke of the \$605,000 transfer back to the Town 2% Fund accounted for last year and of its current balance of \$330,000, a total cost of \$1 million when compared to the education cost for that of a special education per student at \$150,000 or more. He also commented on the very detailed grant as having a 3-year time period that is being used for Covid expenditures and the hiring of temporary teachers. Board of Education Member Pike wholeheartedly endorsed the FY 2020-2021 BOE Budget and expressed hope for the support of the Town Council.

No comments were received by email nor from attendees online.

#### 5. Adjournment

Motion by Councilor Bunnell; seconded by Councilor Jaskiewicz to adjourn the meeting at 6:14 p.m. Discussion: none. Voice vote, 5-0, all in favor. Meeting adjourned.
